**2017 REALTOR® DUES PRORATION CHART**

**Please read carefully:** Dues are calculated per date of association as filed by your Principal with the RI Department of Business Regulation. Per Article X, Section 2(a)(1) of our Bylaws, Dues shall not be prorated if an individual held a membership during the preceeding calendar year, and a Reinstatement Fee in lieu of Application Fee will apply. Reinstatement Fees for Associates are \$125. Reinstatement Fees for Principals are \$150. If you are applying as a New Principal/Office, the Application Fee is \$200, not \$100. The Board shall not process any application whose payment is incorrect and/or lacks the required documentation below. 4. A Board Certification Form if you are a new Principal/Office.
5. If you are transferring from another Board, please provide a letter of good standing from your previous Board.
6. If you are transferring from another Board, please provide a copy of your Code of Ethics class certificate for the 1/1/17 - 12/31/18 biennial.
